PROPOSED GUIDELINES ON TERMS OF ENGAGEMENT, SCOPE OF WORKS AND REMUNERATION GUIDE FOR CONSULTING INTERIOR DESIGNERS IN KENYA.

CHAPTER 1: TERMS OF ENGAGEMENT.

SECTION I: CONSULTING PROVISIONS

1.1.Declaration of these guidelines.

It is hereby declared to be the Intent of Interior Design Profession to safeguard life, health, property, and public welfare, consistent with the principles of sound and professional practice in the built environment;

These guidelines issued by State Department for Public Works provide for Interior Design Professionals and stakeholders including clients, a framework of minimum standards and requirements to guide and control professional engagement in Interior Design practice.

For purposes of these guidelines, a Consulting Interior Designer shall;

- a) Mean either
 - i) Such a natural person in possession of qualifications and experience suitable for undertaking interior design services as shall be administered by an Association the natural person is prescribed to; or
 - ii) Such a body corporate validly registered as a firm member with a professional association dealing with matters interior Design.
- b) Show cause prescription to the Code of Ethics and Professional Conduct for Interior Design Practice in Kenya prior to being engaged to offer such services identified under the schedules;
- c) Be able to perform the services identified in these guidelines; and
- d) Exhibit other skills, care, diligence, efficiency and conduct reasonably expected from such a consultant

These guidelines shall be governed by, construed to be in accordance with the Laws of the Republic of Kenya and be used in administration of provisions of the Public Procurement and Asset Disposal Act of 2015 and any other applicable law.

1.2.Interpretation and Definitions

1.3.GENERAL CONDITIONS.

1.3.1. Selection of a Consulting Interior Designer.

The client shall identify the need to appoint a consultant to provide for Interior Design Services and other services set out in the schedules. The Consulting Interior Designer may agree to accept such appointment upon and subject to the terms and conditions set out in the Contract.

1.3.2. Commencement of Interior Design Services.

The Consulting Interior Designer will commence the project as soon as the specific proposal documents have been accepted and signed off by the client.

1.3.3. Consulting Interior Designer who carries on business as an interior design firm.

- **1.3.3.1.** The Consulting Interior Designer who is the principal partner and carries on business in interior design practice may offer interior design services as a consulting interior design firm and shall be incorporated in the memorandum of agreement as such.
- **1.3.3.2.** Interior Design consultancy services provided by a consulting interior design firm shall be in accordance with these guidelines.
- **1.3.3.3.** The interior design firm shall be remunerated solely by fees payable by the client for interior design consultancy services provided.

1.3.4. Engagement of other consultants by Client.

The Consulting Interior Designer shall advise the client on the need for other consultants to be engaged for any part of the project and unless otherwise agreed upon, the consultants shall be engaged and paid by the client.

1.3.5. Engagement of other consultants by the Designer.

A consulting interior designer may be required to engage his own consultants and if the engagement is approved by the client, the fees which would have been payable to such consultants if they were separately engaged shall be paid through the Consulting Interior Designer.

1.3.6. Coordination of Consultants' Works

A consulting interior designer shall instruct the consultants and coordinate the consultants' works where required, whether the consultants are engaged pursuant to subsection 1.3.4. or 1.3.5.

1.3.7. The Consulting Interior Designer not liable for acts of consultants engaged by client. Where consultants are engaged by the client for any part of the project pursuant to sub-

section 1.3.4, a Consulting Interior Designer shall not be liable for their performance, acts or omissions.

1.3.8. The Consulting Interior Designer responsible for acts of consultants engaged by him

Where consultants are engaged for any part of the project pursuant to sub-section 1.3.5, a consulting interior designer shall be primarily responsible for their performance, acts or omissions

1.3.9. Duties of the Consulting Interior Designer to be accurately described.

The client shall not enter into any contract with, nor make any representations to, any third party which describe the consulting interior designer's duties and responsibilities in a manner inconsistent with the terms of agreement.

1.3.10. Appointment of another Consulting Interior Designer

- 1.3.10.1. In the event that the Memorandum of Agreement between a consulting interior designer and a client is terminated for a reason not due to the fault of either party, a consulting interior designer shall, subject to the rights of either party in respect of antecedent breaches of the Memorandum of Agreement between the two parties, charge the balance of fees for the interior design consultancy services rendered up to the stage of termination together with all reimbursable charges.
- **1.3.10.2.** After full settlement of all fees and charges due from the client, the consulting interior designer shall issue a letter of release to the client and the client shall be entitled to appoint another consulting interior designer to continue with the project.

1.3.11. Client's Agreement.

- **1.3.11.1.** A Consulting Interior Designer shall obtain a written agreement from the client in respect of remuneration for Interior Design Consultancy Services to be provided within **sixty days** (60) from the date of the notification regarding such remuneration is duly served on the client.
- **1.3.11.2.** Notwithstanding sub-section 1.3.11.1, where the client's agreement in writing is not obtained within the period as stipulated in sub-section 1.3.11.1but the client agrees by his conduct to the terms of engagement and the scale of fees and charges, the client shall for the purposes of sub-section 1.3.11.1 be considered to have agreed to such terms of engagement and scale of fees and charges.

1.3.12. Instructions or variation orders.

A consulting interior designer shall not issue instructions or variation orders including changes in the design, without the prior approval of the client, unless;

- i. Such instructions or variation orders are statutory requirements or necessitated for safety reasons;
- **ii.** The client is informed in writing of the action taken as soon as practicable; and
- **iii.** The amount in respect of the variation works is within an amount that has been pre-agreed between the client and the consulting interior designer and is specified in the Memorandum of Agreement or any amendments to such agreement.

1.3.13. Inspection of Works

A consulting interior designer shall inspect the works at periodic intervals as required and where more frequent or constant inspection is considered to be necessary –

- i. May recommend to the client the employment of a clerk of works with requisite skills in interior design, resident interior designer or other personnel, where the cost of employing such person shall be borne by the client; or
- **ii.** May, if the client agrees, second to the project, personnel under the consulting interior designer's employment, where the consulting interior designer shall be reimbursed on the basis of time costs multiplied by a multiplier as agreed between him and the client.

1.3.14. Estimates of costs and time.

A consulting interior designer shall estimate the costs and the time for the project to be completed and shall keep the client informed of any material& process changes in such estimates of costs and time.

1.3.15. Entitlement to documents.

- **1.3.15.1.** Where the Consulting interior designer has rendered the consultancy services up to and including the contract documentation phase and has received his due fees, the client is entitled to reproduce the design for the purpose of implementing the project provided that the project is on the site on which the design was originally prepared.
- **1.3.15.2.** The entitlement to utilize the original design as stipulated in sub section 1.3.15.1. shall be applicable to the maintenance, repair, renewal, reinstatement or modification of the project.

1.3.16. Client to provide all information.

A client shall provide the consulting interior designer with all the necessary information on requirements for the project to enable the consulting interior designer proceed with the project, including particulars concerning existing structures and features of the site, sub-surface conditions and adjoining sites, unless such particulars are agreed not to be provided to the consulting interior designer under the Memorandum of Agreement.

1.3.17. Client's authorized representative.

A client shall designate, if necessary, a liaison person who will maintain regular contact with the consultant on matters regarding the project.

1.3.18. Instructions to contractor.

A client shall only issue instructions to the project contractor undertaking interior design works through the Consulting Interior Designer.

1.3.19. Dispute Resolution

- **1.3.19.1.** If there is a dispute between parties arising under the Agreement, either party shall give a notice in writing to the other party informing him/her of the matter in dispute and requiring its settlement.
- **1.3.19.2.** The Party claiming a dispute has arisen must give written notice to the other party specifying the nature of the dispute.
- **1.3.19.3.** The parties shall appoint an arbitrator within (14) fourteen days from the date of the notice.
- **1.3.19.4.** If the parties fail to appoint an arbitrator within fourteen days from the date of the notice, either party may apply for a nomination or appointment to be made by the Association the consulting interior designer is a member of, whose award shall be final and binding.

1.3.20. Suspension of Interior Design Consultancy Practices.

- **1.3.20.1.** A consulting interior designer shall, in the event the client fails to pay the fees claimed within the period stipulated in the Memorandum of Agreement, be entitled to suspend his/her services not amounting to a termination, where the suspension commences upon the Consulting Interior Designer having duly served a written notice of suspension to the client.
- **1.3.20.2.** The suspension under Sub-Section 1.3.20.1. shall remain in force until the fees are paid or settled, or in the event of a dispute, until the matter is referred for resolution as provided for in these guidelines and rules made thereof.

1.3.21. Termination of engagement.

- **1.3.21.1.** The Memorandum of Agreement between a consulting interior designer and a client may be terminated at any time by either party serving upon the other party a written notice of termination, where such termination shall take effect after a period of sixty days from the date of the written notice, or such shorter period as may be agreed upon between the parties.
- **1.3.21.2.** Notwithstanding the service of notice of termination under sub-section 1.3.21.1. a consulting interior designer shall continue to provide consultancy services until the date of termination of the Memorandum of Agreement.
- **1.3.21.3.** Upon termination of Memorandum of Agreement, fee for the services completed shall be calculated in accordance with procedures to be agreed between the consulting interior designer and the client.
- **1.3.21.4.** For purposes of Sub-Section 1.3.21.3, an Agreement shall be deemed to be terminated where services are deferred or suspended for a period of more than 90 calendar days in aggregate, unless otherwise agreed in writing by the parties.

1.3.22. Death or incapacity of a consulting interior designer.

- **1.3.22.1.1.** In event of death or incapacity of a consulting interior designer who is a sole proprietor, the consulting interior designer's engagement shall be regarded as terminated.
- **1.3.22.1.2.** The client may, on payment of all outstanding fees and other dues in respect of the engagement of the consulting interior designer, make use of all drawings and documents prepared by the consulting interior designer, provided that they are only for the purpose of implementing the project on the site on which the design was originally prepared.

1.3.23. Copyright of documents

Copyright of all design works, plans and documents, will remain the property of the consulting interior designer. The client shall be entitled, on payment of all fees and other project-related costs, to use the design works, plans and documents for the specific purpose for which they were prepared, but for no other purpose.

1.3.24. Client not infringe the terms of the agreement.

A client shall not enter into any contract with, nor make any representations to, any third party which describe the consulting interior designer's duties and responsibilities in a manner inconsistent with terms of the agreement.

SECTION II: MEMORANDUM OF AGREEMENT.

1.4. FORM OF AGREEMENT BETWEEN A CLIENT AND A CONSULTING INTERIOR DESIGNER FOR INTERIOR DESIGN SERVICES.

- 2. This Agreement comprises this form of agreement together with the following documents which shall be deemed to form and be read and construed as part of this Agreement.
 - a. Terms of engagement for consulting interior design services
 - b. Obligations of a consulting interior designer
 - c. Remuneration and payment of a consulting interior designer
 - d. Contract conditions and schedule of services
- 3. In consideration of the payment to be made by the client as hereinafter mentioned, the consulting interior designer hereby agrees to perform the Services in conformity with the provisions of this Agreement.
- 5. The additional services to be carried out in accordance with subsection 1.7.3.of the said terms of engagement shall be;

- 6. The terms of this Agreement have been explained in the context of the client's rights as a consumer.

1.5. OBLIGATIONS OF A CONSULTING INTERIOR DESIGNER.

1.5.1.Performance of Services.

A consulting interior designers shall perform Normal Services, as so prescribed in sub section 1.7.1. and such Additional Services so prescribed in sub section 1.7.3. and as may be requested or consented to by the Client.

1.5.2. Skill and Care

A Consulting Interior Designer shall exercise reasonable skill, care and diligence in performance of his/her services.

1.5.3.Assignment

- **1.5.3.1.** A consulting interior designer shall not, without a written consent of the Client, unreasonably delay or withhold, assign or transfer any benefit or obligation under his/her Agreement.
- **1.5.3.2.** A consulting interior designer will be expected to work closely with other project consultants and attend all site meetings with the Consultants and Specialists

1.5.4. Acting as Lead Consultant

- **1.5.4.1.** A consulting interior designer shall if so, indicated by the Client prior to the execution of the Agreement to act as the lead consultant, Act so to coordinate and integrate the services of such other consultants as the Client may appoint.
- **1.5.4.2.** The consulting interior designer will not be responsible for the detailed designs of any other Consultant or liable for defects in or omissions from them.

1.5.5. Working with Specialists Sub-Consultants

- **1.5.5.1.** A Consulting Interior Designer may recommend to the Client that the Consulting Interior Designer sub-lets to a specialist sub-consultant the performance of any of the Services.
- **1.5.5.2.** The Client shall not unreasonably withhold consent to such recommendation and the Consulting Interior Designer shall integrate such sub-consultant's services with his own.
- **1.5.5.3.** The Consulting Interior Designer shall be responsible for the performance and the payment of any sub-consultant.

1.5.6. Design by Contractors or Sub-Contractors

- **1.5.6.1.** A consulting interior designer may recommend that specialist suppliers and/or contractors should design and execute certain part or parts of the project in which circumstances the consulting interior designer shall co-ordinate the design of such part or parts with the overall design but he shall be relieved of all responsibility for the design, manufacture, installation and performance of any such part or parts of the Works.
- **1.5.6.2.** Where any persons are engaged in accordance with sub section 1.4.5.1,the Consulting Interior Designer shall be under no liability for any negligence, default or omission of such persons.
- **1.5.6.3.** If the Consulting Interior Designer shall be required to incorporate proposals by others in his/her scheme, he/she shall not be responsible for the design or performance of the proposals designed by others.

1.5.7. Appointing a Project Leader

A consulting interior designer shall designate a project leader approved by the client who shall be deemed to have authority to make decisions on behalf of the consulting interior designer under the Agreement. The project leader shall not be replaced without the consent of the client, which consent shall not unreasonably be delayed or withheld.

1.5.8. Limit of Authority

- **1.5.8.1.** A consulting interior designer shall not, without the further approval of the client, alter the design once approved by the client; save in the event of any emergency,
- **1.5.8.2.** The consulting interior designer shall not without the approval of the client issue instructions to any contractor the effect of which would be to alter any design already approved by the client or to incur additional costs to the client beyond whatever limits may have been agreed for such additional costs.

1.5.9. Bills of Quantities

- **1.5.9.1.** The consulting interior designer shall advise the client on the need for preparing bills of quantities in respect of the Works before invitation of tenders thereof.
- **1.5.9.2.** The preparation of bills of quantities forms part of scope of work for the consulting interior designer.
- **1.5.9.3.** Specifically, the consulting interior designer shall:
 - i. Prepare detailed bills of quantities for the project if the design of the project is sufficiently advanced to enable him/her to do so, or

- **ii.** Prepare any bills of approximate quantities for the Works if the design of the Project is not sufficiently advanced to enable him to prepare detailed bills of quantities.
- **iii.** Prepare priced bills of quantities for accurate cost estimates.
- iv. Execute any other quantity surveying works as necessary.
- v. In any case in which the consulting interior designer has prepared bills of quantities, he/she shall subsequently correct the quantities and re-price the bills.

1.5.10. Liability of the Consulting Interior Designer

If the consulting interior designer shall be found liable to the client (whether under the express or implied terms of this agreement, in negligence, or otherwise at common law) for any costs, loss or damage suffered by the client, however caused and of whatever nature, arising out of or connected with the performance or failure of performance of services by the Consulting Interior Designer, then the maximum amount of that liability in total for the aggregate for all such claims against the Consulting Interior Designer shall not exceed the total value of the Consulting Interior Designer's fees.

1.5.11. Mitigation of Consulting Interior Designer's liability

- **1.5.11.1.** Liability of a consulting interior designer to the client against loss or damage as aforesaid in sub section 1.5.10 shallbe reduced proportionately to the extent that any act or omission of the client (*whether amounting to a breach of this agreement or not*) has contributed towards any such loss or damage.
- **1.5.11.2.** The client may at any time request the designer to produce a proof of a professional indemnity insurance cover

1.6. OBLIGATIONS OF THE CLIENT.

1.6.1. Provision of Information

The Client shall supply to the Consulting Interior Designer, without charge and in such time so as not to delay or disrupt the performance by the Consulting Interior Designer, project brief, project cost, project programme and relevant data and information (including details of the services to be performed by any Other Consultants) in the possession of the Client, his agents, servants, other Consultants or Contractors.

1.6.2.Payment for Services

The Client shall pay the Consulting Interior Designer fees and disbursements for the performance of the Services as set out in chapter 2 of these guidelines.

1.6.3. Providing Assistance

The Client shall give, and shall ensure that his/her agents, servants, other consultants and contractors give, such assistance as shall reasonably be required by the Consulting Interior Designer in the performance of the services.

1.6.4. Making Decisions

The client shall ensure that his/her decisions, instructions, consents or approvals on or to all matters properly referred to him/her shall be given in such reasonable time so as not to delay or disrupt the performance of the services by the Consulting Interior Designer.

1.6.5. Assignment

A client shall not, without the written consent of the Consulting Interior Designer, which consent shall not unreasonably be delayed or withheld, assign or transfer any benefit or obligation under this Agreement

1.6.6. Appointing Client's Representative

The client may designate a representative who shall be deemed to have authority to make decisions on behalf of the client under this Agreement. The client shall notify the Consulting Interior Designer immediately if the representative is replaced.

1.6.7. Appointing Contractors

- **1.6.7.1.** The client shall appoint contractors to execute and/or to manage the execution of the project and the works.
- **1.6.7.2.** The client shall require that the contractors execute the project and the works in accordance with the terms of the relevant contracts.
- 1.6.7.3. Neither the provision of site staff nor periodic visits by the Consulting Interior Designer or his staff to the site shall in any way diminish the responsibilities of the contractors or any sub-contractors for executing the project and the works in compliance with the relevant contract documents and any instructions issued by the Consulting Interior Designer.

1.6.8. Transitional provisions

- **1.6.8.1.** All actions, engagements, directions, approvals or decisions done, made or given before the commencement of these guidelines shall continue to have effect, until they expire, are terminated or revoked, as the case may be.
- **1.6.8.2.** All fees or expenses payable for an Interior Design consultancy practice or specialist consultant prior to commencement of these guidelines shall continue to be made.

SECTION III: INTERIOR DESIGN SCOPE OF SERVICES.

1.7. Types of Interior Design Consultancy Services

Interior Design consultants shall provide any or all of the following services:

- i) Normal Services;
- ii) Supplementary Services;
- iii) Additional Services

1.7.1. NORMAL SERVICES.

These are basic project services provided by the Consulting Interior Designer, causing the basis of retaining the consultant. However, the nature of each project will determine the scope of the services required.

The scope of Interior Design work in a normal building project includes design, specification of ceiling, wall and floor finishes, and particularly in;

- 1. Selection, documentation, facilitation of procurement and installation of furniture and related fittings and wood joinery; layouts & arrangement.
- **2.** Determination of soft furnishings including carpets; window treatments including blinds, other fixtures including lighting& sanitary ware and loose equipment including appliances.
- **3.** Advise and determine Colour & schemes; other painting works including special effects; and any final wall finish material.
- **4.** Determination and specification of floor finishes; interior plant selections and placement.
- **5.** Coordinate provision of works of art including ironmongery; and other decorative accessories.
- **6.** Other Design work arising from a building project including signage.

1.7.1.1.Phases for Normal Services.

The basic services that may be provided by a Consulting Interior designer shall be for any or all of the following phases:

- i) Schematic Design Phase;
- ii) Design Development Phase;
- iii) Contract Documentation Phase;
- iv) Contract Implementation and Management Phase;
- v) Final Completion Phase

1.8. Project Management Consultancy Services

The project management services may be any or all of the following:

- i) providing project management consultancy services from the inception to completion of a project, including preparing of project briefs, appointing and coordinating with consultants, contractors and suppliers, preparing various levels of project schedules for the planning, implementation and monitoring all the activities and elements related to the agreed targets, preparing reports and their submission to the client, and accepting the completed works on behalf of the client:
- **ii**) providing periodic or full-time site staff for frequent or constant inspection of a project;
- **iii**) providing full services required for project management in serving as the overall coordinator where separate contracts for each trade are awarded;

1.8.1. Consulting Interior Designer as a Project Manager.

- i) The Project Manager coordinates the logistics of a Project and activities of other Consultants as they relate to the Client. The project manager shall not take professional responsibility for the performance of any of the other Consultants.
- **ii**) The Consulting Interior designer as the Project Manager shall be the client's representative on the project team for the coordination of logistics and general support services as required by the nature of the project.
- iii) A Consulting Interior Designer shall not practice as a project manager unless attained the tier (3) category of membership a provided in schedule I of these guidelines
- iv) The Project Management shall constitute an additional service for a Consulting Interior Designer and its remuneration shall be in accordance with sub section 1.7.3.

CHAPTER 2.0: REMUNERATION GUIDE.

2.1 General rules

Guided remuneration arising from these guidelines shall be VAT exclusive. However, Final remuneration shall include all applicable statutory fees including VAT.

2.1. Methods Of Remuneration.

Fees for the below mentioned engagements shall be based on one of the three methods of calculation.

2.1.1. TIME COST BASED MODEL

a) For Normal Services.

- i) Projects, Programmes and Works offered by a Consulting Interior Designer as **Normal Services** may be remunerated based on hourly rate basis as tabulated under table 2.1.1.
- **ii**) Schedule I on Categorization and Qualification of a Consulting Interior Designers shall **APPLY** on this sub section.
- **iii**) Working hours of a Consulting Interior Designer shall be in compliant with provisions under the Employment Act, Cap 226 No11 of 2007 of the Laws of Kenya
- **iv**) Without prejudice to sub-section iii) above, parties involved may agree on such other working hours or days and determine remuneration thereof.

2.1.2. FIXED CONTRACT/LUMP SUM FEE BASED MODEL

- 1. For purposes of calculating interior design consultancy fee in a tendered project, the cost shall be calculated based the accepted tender cost-plus other provisions that may be provided;
- **2.** For purposes of calculating interior design consultancy fee where no tender documents is required, the cost can be mutually agreed based on fair assessment of the engagement;
- **3.** For purposes of calculating interior design consultancy fee in a tendered project, the cost of a single item to be supplied in the project whose cost is more than Kshs. 500,000 will be deducted from the accepted tender cost as tabulated below

2.1.3. PERCENTAGE FEEBASEDMODEL.

- **2.1.3.1.** Remuneration for normal services for design Stages I and II shall be 3.9% of the estimated Project Cost for new projects, and 4.2% for services on existing structures all of which shall be adjusted appropriately at the end of Design Stage for the final fees payable to the Consulting Interior Designer.
- **2.1.3.2.** For purposes of calculating remuneration under supplementary services, the percentage fee shall be mutually agreed based on fair assessment of the engagement. The agreed percentage shall be added to the agreed normal fee percentage.
- **2.1.3.3.** Services offered under additional services shall attract a minimum percentage fee of 4.2% the project plus any other percentage mutually agreed based on fair assessment of the engagement.

2.2.DETERMINATION OF COST OF WORKS

The cost of Interior design works shall be determined:

- **2.2.1.** For completed works, the original contract sum or if there are variations to the works, the final cost of works including variations;
- **2.2.2.** For works tendered but not awarded, the lowest acceptable tender as agreed by the consultant and the client less contingency sum; and
- **2.2.3.** For works where tenders have not been received, the latest estimate of costs prepared by the consultant or other consultants and accepted by the client

2.3.OTHER REIMBURSEMENTS.

- **2.3.1.** Out of pocket expenses incurred by a Consulting Interior Designer on design and production of final drawings and documents shall be covered under the Consulting Interior Designer's normal fee.
- **2.3.2.** Pursuant to sub section 2.3.1, purchase, printing, and production of all documents, drawings, bills of quantities, maps, models, 3D renders, photography or other records required in connection with the design or construction of the projects will be reimbursed upon presentation of detailed invoices with supporting receipts. Payment shall be actual cost plus 15%.
- 2.3.3. The client will reimburse expenses incurred by a Consulting Interior Designer for at least one visit to the site during the design stage. Reasonable hotel and subsistence expenses consistent with seniority of consultant's staff as laid down in Schedule I of these guidelines or as stipulated by a circular of rates and cluster classification for purposes of payment of daily subsistence allowance for Government officers by Salaries and Remuneration Commission shall apply.
- **2.3.4.** Cost of telephone calls, airtime, internet charges, other postages and similar communications will be reimbursed.
- **2.3.5.** Expenses incurred in respect of advertising for tenders, site staff, and the time and expense for interviews shall be reimbursed.
- **2.3.6.** Expenses incurred from County Governments or Other Statutory Organizations, inspection or similar charges shall be reimbursed.
- **2.3.7.** Such unforeseen expenses incurred in respect of undertaking preliminary studies, surveys, research-works and other fact-finding activities shall be reimbursed.
- **2.3.8.** Any payment made on behalf of and with prior approval of the client, shall be reimbursed
- **2.3.9.** Any other reimbursements as may be agreed between parties

2.4. PAYMENT TIME LIMIT

- **2.4.1.** Payment notices for installments of fees, remuneration and reimbursements shall be issued and paid in accordance with agreed drawdown schedule.
- **2.4.2.** Payment notices issued under clause 2.5.1. shall be honored within **21** working days, failing which shall attract interest at 2.5 % above prevailing bank rate for the period of delay.
